

SEGL Figure Skating Council IJS EQUIPMENT USER AGREEMENT

This SEGL IJS Equipment User Agreement (“User Agreement”), made on _____ by and between the Southern Eastern Great Lakes Figure Skating Council (“SEGL”), who for purposes of IJS Equipment Rental, the mailing address is SEGL, Mark Chastain – Treasurer, 963 Wedgewood Drive, Independence, KY 41051, and _____ (hereinafter referred to as "User"), located at _____.

In consideration of the mutual covenants and promises set forth in this User Agreement, the parties agree as follows:

1. **Use:** SEGL agrees to allow User the use of **one set of IJS Equipment** (“SEGL Equipment”) to be used for the following event: _____.

2. **Use Period:** This User Agreement shall be for _____ **day(s)** and shall commence on the date of delivery of the SEGL Equipment to User. **The term shall be for** _____.

3. **Fees:** For the Use Period above, User agrees to pay SEGL a daily rental fee of \$50, payable by check only, plus possible additional rental fees based on User club status. See additional Protocol and Rental Procedures documents for complete details.

User will be responsible for supplying the following equipment:

- Computers/laptops as deemed necessary by the LOC.
- Any other equipment necessary for the accounting of an IJS event.
- Camera operator and equipment to provide the video feed.

5. **Use:** User shall use the SEGL Equipment in a careful and proper manner and shall comply with and conform to all governmental laws, ordinances and regulations relating to the possession, use and maintenance of the Equipment as well as the instructions provided with it.

User shall be responsible for set-up of the SEGL Equipment and shall have at least one (1) U.S. Figure Skating approved technician on its officials' roster to set up, take down and operate the Equipment for the duration of the User Agreement. User shall also have at least one (1) U.S. Figure Skating approved data entry specialist on its officials' roster for the duration of this User Agreement.

6. **Delivery:** The SEGL Equipment is NOT approved for commercial shipping. The SEGL will work with the User to determine an acceptable method of delivery via Officials, Coaches or other reliable party. The User shall be responsible for returning the equipment to the designated delivery party.

7. **Alterations:** Without the prior written consent of Owner, User shall not make any alterations, additions, or improvements to the SEGL Equipment during the Use Period.

8. **Loss and Damages:** The SEGL agrees to provide the SEGL Equipment in working order, but makes no further representations concerning its performance during the Use Period. The SEGL maintains insurance on the equipment while in possession of the User. However, the User assumes the entire risk of loss or damage to the SEGL Equipment for causes deemed to be Dishonest Acts, Equipment Disappearance, Shortage During Final Inventory, Theft (unless forced entry), Unauthorized Equipment Changes and/or System Delivery to Unauthorized Party.

9. **Indemnification:** User agrees to defend, indemnify and hold the SEGL harmless against any and all liability, losses or damages arising from User's use of the Equipment. This also includes liability, losses or damages arising from any act or omission by User, its agents, representatives, or employees that result in any liability, losses, claims or demands, damages, or causes of action arising from the alleged negligent or willful or wanton misconduct of User, or its agents, representatives, or employees.

10. **Entire Agreement:** This instrument constitutes the entire agreement between SEGL and the User; and it shall not be amended, altered, or changed except by a written agreement signed by them.

11. **Governing Law:** This User Agreement shall be governed by and construed in accordance with the laws of the State of Kentucky.
